

Please find below information regarding your entry to **Metropolitan France**:

The country color code has been used to reflect the information available from the <u>French Ministry of Interior</u>, and please find here below the summary of this situation to date with 3 main categories:

## • Group 1:

Travelers arriving from countries without need of a self-isolation or quarantine in France or Monaco. Documents to be presented upon arrival to transit to Monaco easily (via private transfer organized by the FIA): ACM invitation letter that the FIA will send you one week prior the event, a confirmation of your hotel reservation in Monaco, a proof of a negative PCR test and a sworn statement attesting the absence of symptoms of covid-19 infection and contact with a confirmed case of covid-19 (Optionally: a proof of vaccination/vaccinal passport if applicable).

## Group 2

<u>Vaccinated</u> travelers (a certificate must be provided) arriving from countries without need of a self-isolation or quarantine in France or Monaco and no compelling reason required. Same documents as for Groupe 1 will have to be presented on arrival.

<u>Unvaccinated</u> travelers from those countries are normally subject to 7 days self-isolation in France. However, in Monaco no quarantine nor self-isolation are required. As a result, the same documents as for Groupe 1 should enable to transit from Nice airport to Monaco via private transfer organized by the FIA. In addition, as a compelling reason must be given to enter Metropolitan France, the FIA will provide a letter from the FIA with the emphasis on the compulsory notion of participation to the conference which should also facilitate the obtention of visas.


## • **Group 3**:

Travelers arriving from countries which are normally not allowed to enter EU/Schengen area or allowed to enter under exceptional circumstances subject to a quarantine of 7 days (if vaccinated) or 10 days (if unvaccinated) on arrival. For this Group, a quarantine of 7 days is normally required in Monaco but can be replaced by a commitment to take a PCR test 24hrs after arrival, and 5 days after (organized by the FIA at the Conference venue). Therefore, the same documents as for Groupe 1 should enable to transit from Nice airport to Monaco via private transfer organized by the FIA. Before arrival, the FIA will provide you in addition to the mention documents above a letter from the Monaco government with the emphasis on the compulsory notion of participation to the conference to facilitate the obtention of your visas, as this might be a challenge for you, and entry to Metropolitan France;

Please find below information regarding your entry to **Monaco measures:** 

As for the <u>requirements in the Principality</u>, we would like to remind that anyone, whatever their nationality, who enters the Principality and comes from a foreign country must be able to justify, in the event of a control by the Monegasque authorities, the negative result of a PCR test, carried out less than 72 hours before arriving in the Principality.

These requirements are re-assessed regularly by the French and Monegasque authorities, and we will update you should there be a change before the Conference.
