# SANITARY PLAN

This document applies for every meetings. Please be beware that being vaccinated or having been previously infected does not exempt you from the protocol.

We rely on a comprehensive sanitary plan which comprises three dimensions:

- Screening measures
- Mitigation measures
- Keeping distance

# **SCREENING MEASURES**

Before the event

## FULL REGISTRATION OF ALL PARTICIPANTS

All participants will be already registered in advance.

## ABILITY TO ATTEND FORM

During the registration to attend the event, the participants will agree to comply with this "sanitary plan" measures. The purpose of this will be to confirm their participation status at the event. When registering onsite, the participants will have to sign and attest they are complying with the measures in place for the event.

## PCR NEGATIVE TEST BEFORE ARRIVAL ON SITE

- During the registration to attend the event, the participants will agree to do a test to detect the Covid-19 virus within 72 hours before traveling on site and to acknowledge the sanitary protocol during their stay.
- Please note that the status declared in this sanitary plan will be definitively confirmed once you have received the
- If a participant is travelling with a partner, the same protocol will be implemented.

# PCR NEGATIVE TEST ON SITE

The FIA sanitary plan prescribes the following:

- For delegate with a valid Health passport (whether EU Digital COVID Certificate or converted), a PCR-test will be mandatory maximum 48 hours after arrival on site.
- For delegates without a valid European health Passport, a PCR-test will be mandatory every 24 hours, as per the regulation in France. The test will be valid 24 hours from the time of sampling.

## TEMPERATURE CHECKS

Temperature measurements at the entrance of each meeting rooms and common shared spaces where need it. Temperature threshold to allow access <37.5°C.

### MEDICAL SERVICE

Health professionals will be on duty at all times. A PCR test device will be available on-site from Monday to Friday.

## MITIGATION MEASURES

## FACE COVERING OBLIGATION

Wearing a face covering will be mandatory in the venue as well as in the meeting rooms. Participants who won't have their own face covering will be provided with one.

#### CLEANING AND DISINFECTION

- We will provide all participants with hydroalcoholic individual solutions. Please use it frequently. We will place hydroalcoholic dispensers in every needed point and at the entrance of all meeting rooms. Surfaces that will be regularly touched (e.g. welcome counters, before the entrance of the meetings, tables, handrails, touch screens) will be regularly disinfected.
  The sanitary facilities of the hotel will be cleaned at high frequency. Hand washing and disinfection facilities will
- be provided at frequent intervals.

## SUFFICIENT VENTILATION

The hotel will be equipped with efficient ventilation systems.

## **CONTACTLESS WAY**

Door systems other than fire doors will be permanently opened to reduce contact with surfaces.

# MAINTAIN SOCIAL DISTANCING

It is a clearly key point to avoid the spread of the virus. We ask all the participants to make sure, as much as they can, to keep required distance with each other.

## NO-HANDSHAKE POLICY

Please do not shake hands and avoid any physical contacts.

# **NETWORKING**

- Please note that due to the current sanitary situation, we will do our best to have side events, such as networking
  opportunities, activities & social events, in compliance with all the restrictions in place. We however depend on
  the measures which will be in place in December, in France and will have further information to provide, closer to
  the General Assembly.
- If a participant wishes to go out of the hotel, we will recommend that he does so with members of the FIA delegation only. Contact with non-pretested persons should be avoided.
- The spaciousness of the indoor and outdoor areas will allow for networking and exchange of ideas while maintaining minimum distances.

#### GENEROUSLY PROPORTIONED SPACE

- We will always ensure that regulatory social distancing will be maintained in each meeting rooms and circulation area.
- To protect all participants, we will adjust the seating and the number of seats. In meeting rooms, standing will not allowed. Where necessary, we will determine separate entrance and exit.
- Please make sure to respect the seating setup in the rooms. If possible, please keep the same place for the entire day.

Attendance at the FIA Annual General Assembly 2021 & FIA Prize Giving 2021 is entirely voluntary. It is acknowledged by all who decide to attend that the measures outlined serve only to mitigate the spread of infection and provide no guarantee against the occurrence of positive cases of COVID-19 during the event.
