

Czech Presidency of the Council of the European Union



Eastern Partnership Media Conference

Date: 1 - 2 December 2022

Venue: Prague, Czechia, Czernin Palace and RFE/RL Headquarters

Context: Free and independent media and professional journalism face many challenges globally, but their situation is especially difficult in the countries of the Eastern Partnership. Russia's illegal and unprovoked aggression against Ukraine exposed the strength of and danger posed by Russian propaganda targeting especially Ukraine, but also other countries in the wider neighbourhood. The Belarusian state became an aggressor, lending its territory for attacks against Ukraine. Its repressive apparatus pushed independent media out of the country. The situation of recurrent war gives media a special role in Armenia and Azerbaijan. The bravery and valuable work of independent journalists from war-torn Ukraine, but also from other countries demonstrate that it is important to invest in the resilience of the media. One of the priorities of the Czech Presidency of the Council of the EU for the Eastern Partnership is the effort to transform the useful concept of resilience into a practical and concrete agenda. Support of independent media and professional journalism is one of the key long-term priorities of Czech foreign policy not only in the Eastern Partnership region.

Objective: To discuss and show practical examples of how to strengthen the resilience of the independent media and professional journalism in Eastern Partnership (EaP) countries; to present current EU media policies, programs and strategies; to renew political commitments towards independent journalism and media freedom; and to contribute to building practical skills strengthening media resilience.

Audieπce: Approximately 100 participants in person: journalists, media professionals, influencers, and media students from Eastern Partnership countries, including Belarusian journalists in exile; RFE/RL journalists and other media from EU countries; participants from EU institutions/member states.

Abstract: Independent media and professional journalism are key components of democratic societies. Alongside the long-standing challenges to media freedom posed by authoritarian regimes, the unjustified and brutal Russian aggression against Ukraine demonstrated that the information war using post-truth concepts, the intrusion of disinformation and manipulative techniques, is a component of the strategy, which can result in unbelievable human suffering and destruction. In the Eastern Partnership countries, the difficulties faced by journalists are extreme, with some countries of the region among the lowest ranking countries on the World Press Freedom Index. Independent media were liquidated in Belarus and professional journalists were forced into exile. The intimidation of journalists by governments, which prescribe content, and the geopolitically motivated intrusion of manipulative information outlets (often sponsored by Russia) are distorting the information space

in other EaP countries. How could the resilience of professional journalism be strengthened? How should the independent media in Eastern Partnership countries deal with these challenges? How can the EU, member states and donors further support the independence of the media in EaP countries? What are the EaP countries' commitments towards preserving media freedom? What legislative framework can adequately regulate the media space facing new challenges? After two years of COVID-19-related isolation, it is high time to renew the concept of EaP independent media conferences in order to reflect on recent changes and chart the way forward.
