# Political/policy context

Education as a theme and youth as one of the main target groups are highlighted in the multi-annual indicative programmes for Southern Neighbourhood countries.

In line with new Agenda for the Mediterranean and its Economic and Investment Plan, support is provided for the delivery of inclusive, efficient, and effective social services, including in the field of education and skills, contributing to the economic and social development.



## Erasmus+ benefits to the Southern Neighbourhood

- Erasmus+ gives an opportunity not only to strengthen the quality of higher education and mobility programs, but also to strengthen the support to capacity building in the areas of vocational education and training.
- Development of Erasmus+ Offices in the Southern Neighbourhood have raised awareness, enhanced cooperation and information exchange on the programme.
- ➢As presented by DG EAC, the Southern Neighbourhood countries are benefitting from various Erasmus+ actions.



### **Erasmus+ and DG NEAR programmes**

- Erasmus+ actions are complementary to DG NEAR regional and bilateral programmes in the Southern Neighbourhood:
  - to support youth and adults to have relevant skills, including technical and vocational skills according to the needs of labour market in the countries;
  - to support education quality and access to education.
- Several countries in the Southern Neighbourhood benefit from Education Budget support to accompany sector reforms.
- Vocational education and training (VET) is an important priority, as a tool to support youth and to the needs for up- and reskilling of the working population in the context of the green and digital transitions in anticipation of emerging skills needs.



#### TUNISIA

- Bilateral programme (Integrated Education Sector Support Programme) in Tunisia approved in 2022 aims at improving the inclusion and performance of the education system in Tunisia.
- The EU is also supporting the education sector with EIB and KfW through the long-term Programme de Modernisation des Etablissements Scolaires, including construction of 800 new schools.



#### EGYPT

- Past and current bilateral programmes in Egypt support TVET reform process with an aim to better respond to the new socio-economic needs, in particular, youth employability and increased competitiveness in the context of the country's current and future development.
- This is complemented by a project funded by the EU (2021-2025) with KfW to promote skills development in the renewable energy sector.



#### LIBYA

- In 2023, the EU adopted a new programme aiming to better align the Libyan workforce skills to the needs of the labour market in the country.
- It will more specifically seek to: (i) strengthen the capacities and services of key public institutions for enhancing employability governance and mechanisms; (ii) reinforce skills and employability on blue/green economy for both private and public sector; (iii) support employability, job creation and facilitating business opportunities for the digital transition; (iv) strengthen capacity and skills of the Financial Sector.
- Previously through a bilateral programme a technical support was provided to the Libyan Ministry of Higher Education and Scientific Research and 12 public universities to address employability, capacitybuilding for entrepreneurship and innovation centres within universities and the introduction of the entrepreneurship curriculum as an accredited course within Libyan universities.



#### MOROCCO

- > The bilateral programme in Morocco aimed at:
  - improving the provision of accessible and quality education and training for all to better respond to the needs of young people and their professional projects;
  - o strengthening social and societal mobilization around the **Education and Training Sector.**



#### LEBANON

- Programme adopted in 2022 aims at improving employment capacities for poor and vulnerable social groups living in Lebanon through TVET.
- Given the challenges faced by the higher education sector in the country since the onset of the financial crisis, the EU Madad funded higher education programme HOPES-LEB has been extended until September 2024. The programme is coordinated very closely with the Erasmus+ National Office.



#### JORDAN

- The EU is a long-standing partner for Jordan in the sector of education new programmes have been adopted to further support quality education (from early education to higher education) and TVET opportunities.
- New programmes will also focus on recovering the education losses from the COVID-19 pandemic and increasing the access to education and TVET opportunities for all in Jordan by supporting scholarship systems.
