Through the governmental initiative, the Central and Eastern European (CEE) countries set the vision for 2030:


to develop knowledge and cooperation based circular bioeconomies, which helps to enhance their inclusive growth and to create new value-added jobs especially in rural areas, maintaining or even strengthening environmental sustainability.

#### **MISSION:**

to assist Central and Eastern European (CEE) countries to operationalize their Vision for 2030 drawing on their potential and offering opportunities for:

- Sustainable increase of biomass production;
- Circular ("zero waste") processing of the available biomass;

• Viable rural areas;

**2021 Declaration**: on the fifth year anniversary of the Initiative, strong commitment behind


**2019 Declaration**: on the role of BIOEAST in the context of Horizon Europe (signed by 22 ministries)

- 11 CEE countries' ministries are working together
- Serbia and Western Balkan countries requested accession (Observer: SWG RRD)
- Set-up of Governance:
  - Secretariat and Secretary
  - National Contact Points
  - More than 25 Board meetings
- 6 international conferences
- 2018 EU Bioeconomy Strategy reference
- 2019 and 2020 European Council Conclusion reference
- 2021 EU Bioeconomy Progress Report
- H2020 CSAs: BIOEASTsUP, Power4BIO, BE Rural, CEE2Act
- H2020 Policy Support Facility
- 7 thematic working groups
- Several national events



### **NEXT STEPS AT NATIONAL LEVEL**

- 1. Concept paper development for National Bioeconomy Strategy Development
- 2. Upscaling the Policy Support Facility results for national bioeconomy strategies with the help of the European Commission
- 3. Establishing National BIOEAST HUBs for the stakeholders engagement at national level



## **NEXT STEPS AT MACRO REGIONAL LEVEL**

- 1. Macro-regional Strategic Research and Innovation Agenda (SRIA)
- 2. Upscaling the results of Foresight exercise for defining the potential future scenarios and priorities
- 3. Enforcing cooperations and networks behind **Thematic Working Groups** for SRIA development and participation in European Partnerships:
  - Forestry value chain ( coordinated by SK)
  - Sustainable yields and agro-ecological intensification (HU)
    - Bioenergy and new value-added products (HR)
      - Food Systems (PL)
      - Fresh water based bioeconomy (CZ)
        - Education and Skills (CZ)
      - Advanced Bio-based materials (HU)






## **KEY DRIVER FOR BIOECONOMY IN CEE**

- 1. EU level policy priorities:
  - ex. Circular economy package
- 2. Bioeconomy measures in sectorial EU policies
- 3. Recognizing the possibility of creating added value at the national/local level.

## **BIOECONOMIZATION OF REGIONS**

- 1. Key policies: research, agri-rural development and regional development-cohesion
- 2. Research pol linked to agri (AKIS), not linked to cohesion
- 3. Bioeconomy core element in reserch programme (Cluster 6), special measure in CAP but not in Cohesion (macro and S3 strategic planning)

We should aim to connect programming in research to cohesion We should aim to introduce bioeconomy as a special measure in cohesion policies
