Introduction

The Global Industry Standard on Tailings Management – GISTM – is the new international Standard organised by the Global Tailings Review, which sets a precedent towards the goal of zero harm to people and the environment with zero tolerance for human fatality.

It was launched in August 2020 and co-convened by the International Council on Mining and Metals (ICMM), United Nations Environment Programme (UNEP) and Principles for Responsible Investment (PRI), which includes the Church of England Pension Board and the Swedish Council of Ethics.

The set of guidelines reinforces current practices in the mining sector by integrating local social, environmental, technical and economic factors, and covers the entire life cycle of tailings dam structures - from site selection, design and construction, through management and monitoring, to closure and post-closure.

Aimed at preventing any harm to people and the environment, the new GISTM sets out significantly more stringent criteria for the industry to achieve sound social, environmental and technical outcomes.

The UK Government in Brazil has been collaborating with Brazil's UNEP office to promote the GISTM to the wider Brazilian audience. This initiative hosted a series of six roundtables throughout 2021 and 2022 to discuss the safety of Brazilian dams from the perspective of the GISTM,

bringing together important stakeholders in the minerals sector, government, academia and civil society to address this decisive theme for the future of mining and the environment.

In order to support mining operations in Latin American in complying with the new Standard, the UK Government have developed this Tailings Management Brochure, which

brings together the best British technologies, equipment and services to contribute to the improvement of the industry, and to become more responsible, transparent, cleaner and safer.

This document is organised by services and solutions according to each GISTM topic, principles and auditable requirements. Committed to supporting the implementation of GISTM principles across Latin American mining companies, and the construction of a safer, cleaner and more responsible sector, the UK Government has the pleasure of presenting this Tailings Management Brochure, showcasing potential UK solutions for mining operators in Latin American to comply with the best practises presented by the GISTM.

Coomtech has brought to market a surface moisture removal technology – Coomtech SMR – and has further developments under way to address trapped and inherent moisture in products. The objective is to assist in selling directly to territories, initially to support and select licensee partners in building a business thereafter.

Coomtech SMR is a bulk solids drying technology designed to remove surface moisture using managed, turbulent air to shear moisture from particles. Particle size target is 5mm and below. Air does all the work, no moving parts in the drying system. System air is at 85C to optimise moisture retention and separation throughout the process plant. Particles pass through in 0.75 of a second. Energy requirements are up to 75% lower and emissions are also up to 75% below thermal drying. Modular systems can be containerised, demountable, integrated or stand-alone, are robust with few moving parts.
