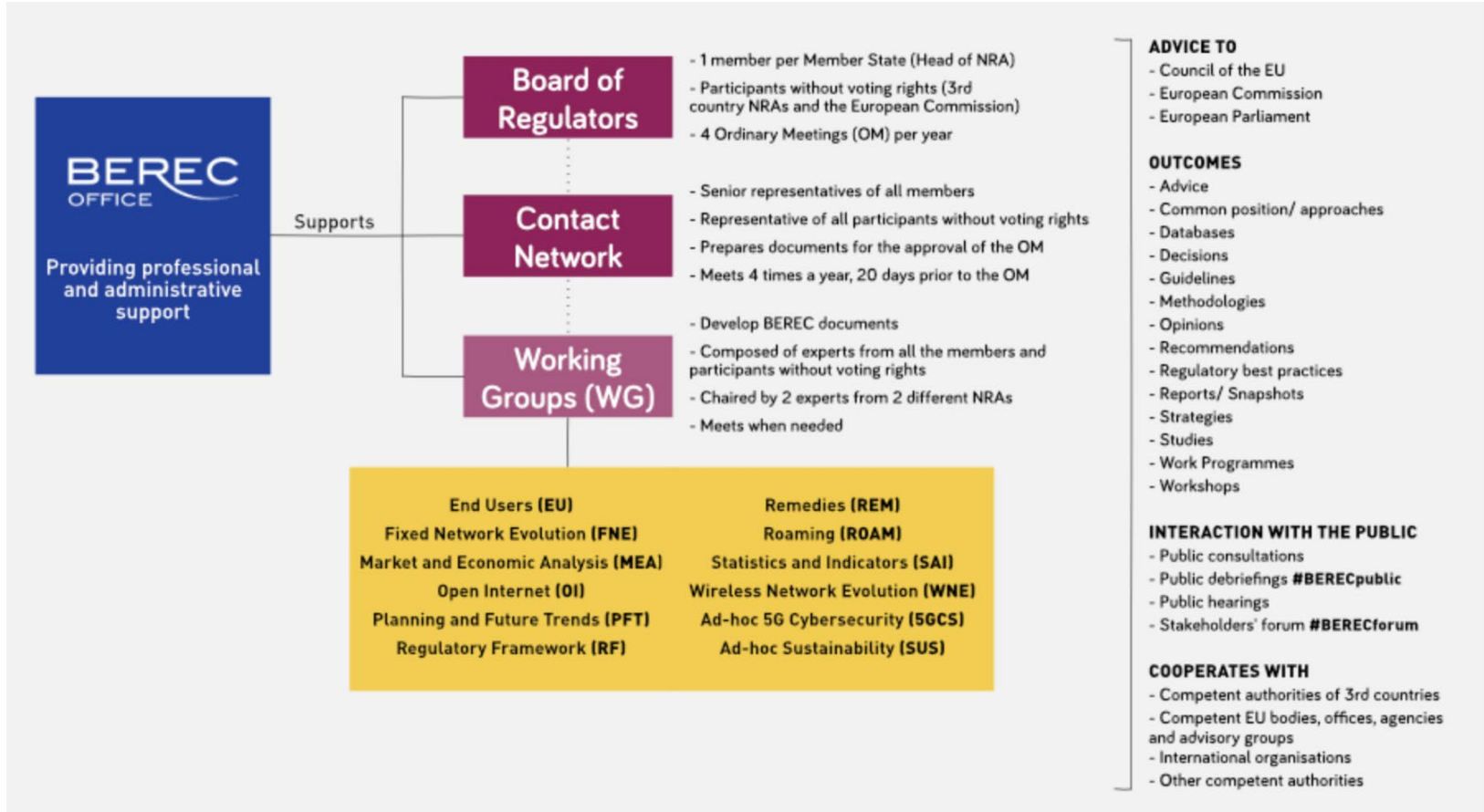

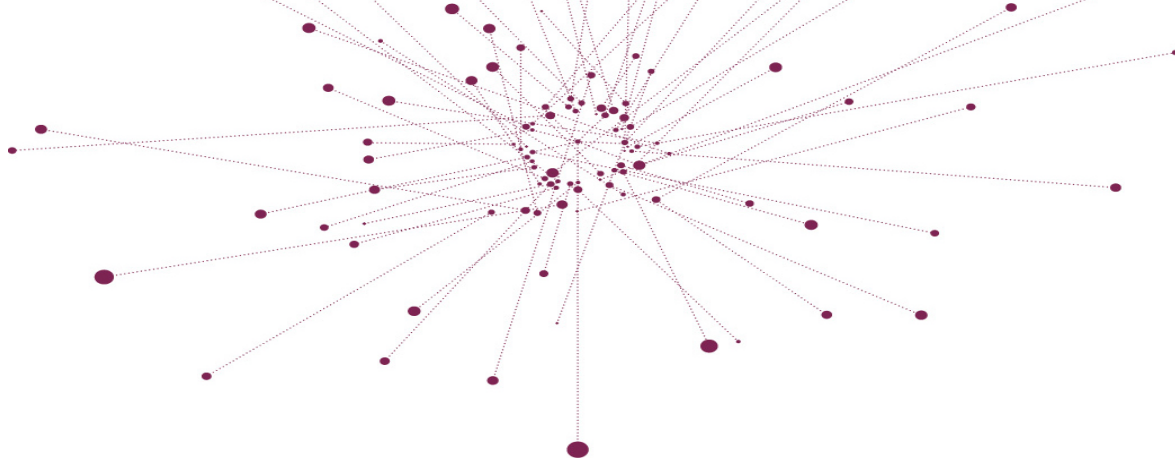
- **In charge of all activities related to economic and market issues.**
- **Mainly focused on aspects related to market analysis in the context of the EECC, and this year also in the DMA**
- **Most of the members of the WG are experts involved in the market analysis departments at NRAs.**
- **Background on microeconomics, but also engineers & lawyers**
- **A variable number of members depending on the year and PRDs. NRAs nominate experts once a year, but it is dynamic. 30-40 members, around 10 of them drafting) divided in different PRDs**
- **The EC also participate in most activities with experts (not drafting, but providing comments and participating in discussions)**
- **Organisation:**
 - **Co-Chairs (coordination, external interaction, defending documents, and sometimes also drafting)**
 - **Drafters (preparing first versions for sections and evolving them based on comments received)**
 - **Members (providing written comments and participating in discussions)**
 - **Experts from BEREC Office (preparing minutes, summaries, processing questionnaires, etc.)**
- **Experts from NRAs are also working on national issues, what is good.**
- **An excellent network of experts to also exchange views on national issues.**

- **Previous year: BEREC workprogramme is prepared and adopted: PRDs assigned to WGs**
- **December-January: call for experts**
- **January: First meeting (agreement on splitting of work)**
- **Iterations preparing drafts, commenting and discussing. Mainly done by VCF. Works well.**
- **Workshops with stakeholders may take place (some of them open to public)**
- **Questionnaires for NRAs and operators, when needed, are sent and processed.**
- **Delivery to CN: 10 days before CN**
- **Once sent to CN, out of control of the WG, just changes agreed at CN**
- **Delivery to Plenary: 10 days before Plenary**
- **Approval by BoR: publication (if not internal)**
- **Most reports to be subject to PC: final report to be delivered two plenaries later including a summary of responses received.**
